Murray Country Club Membership & Dues Policy

MEMBERSHIP RULES AND POLICIES

Application Form

A membership application package may be obtained from the Pro Shop, Clubhouse, or Business Manager's Office. Once completed, the application should be sent with payment. In accordance with Club Bylaws, the application will be approved by the Membership Committee, posted on the club bulletin board for seven days, and then voted by the Board of Directors at the next regular Board meeting.

Please note, although we offer a monthly payment option, membership is on an annual basis. The Murray Country Club Dues period is based on a fiscal year, from January through December. Murray Country Club does not offer summer memberships, but does offer pro rated dues from date of joining.

MEMBERSHIP OPTIONS AVAILABLE

Full Family Membership

- Full family memberships are limited to husband, wife and all single dependents under age 23, living in the same household.
- Full family memberships apply to a single parent with single dependents under age 23, living in the same household.
- Full family members are entitled to the use of all Club facilities.
- Full family members are entitled to one vote per membership, and may hold elected office.

Full Single Membership Rules

- Full Single memberships apply only to the individual member, and do NOT include any children.
- Guests may attend scheduled social events, and visit the lounge.
- Single members are limited to one adult (in county) guest per social event.
- The member must accompany the guest.
- Members are responsible for any fees and purchases made by the guest.

Social Membership Rules

- Social members are entitled to use the clubhouse, swimming pool and tennis courts.
- Social members may use the golf course a total of three (3) times a year by paying green fees and cart fees. Participation in any club tournament does not count against the 3 permitted times.
- Social members may not vote or hold elective office.

Other Out of County Membership

- Applicants who live in a county **OTHER THAN** Calloway, Graves, Marshall, Trigg, Stewart, Henry or Weakley may join as Other Out of County members.
- Other Out of County Members are entitled to the use of all Club facilities.
- Other Out of County Members may not vote or hold elective office.

Young Adult Membership

- Young adult members must be 32 years of age or younger on the 1st January.
- Young Adult Members are entitled to the use of all Club facilities.
- Young Adult Members are granted voting rights.

Seasonal Membership

- Membership dues must be paid in full, no partial or monthly payments permitted.
- Membership is valid Memorial Weekend through Labor Day Weekend inclusive.
- Membership allows access to the Pool, Clubhouse and Tennis Courts ONLY.
- Seasonal members agree to abide by the general pool rules.
- Seasonal members may use the golf course a total of three (3) times a year by paying green fees and cart fees. Participation in any club tournament does not count against the 3 permitted times.
- Seasonal members may not vote or hold elective office.

Privileged Memberships

- Privileged memberships are those memberships that the Board of Directors may approve for individuals or families that should be granted special status, but such memberships shall never exceed 15% of the total memberships. They are not granted voting rights nor can they hold elective office.

Membership Dues Delinquency Policy

- Murray Country Club offers four options for payment of membership dues.
- Option 1 – Annual Dues - Membership dues must be paid on or before Jan 31st
- Option 2 – Semi Annual Dues - Membership dues must be paid in two equal payments on or before Jan 31st and June 30th.
- Option 3 – Three payments – Membership dues must be paid on or before Jan 31st, March 31st and June 30th
- Option 1, 2 and 3: Amounts due and not paid within 30 days of due day will be re-billed plus a \$50 late fee.
- Option 1, 2 and 3: Non-payment of dues after 60 days will result in suspension of club privileges.
- Option 4 – Monthly Billing – Monthly dues must be paid in advance each month via credit card or ACH (automatic bank withdrawal). Members selecting monthly billing must provide a signed payment authorization for monthly payments to the end of the fiscal year.
- Non-payment of Option 4 monthly dues after 30 days will result in suspension of Club privileges.
- Dues Delinquency: A certified letter will be sent to a member who is delinquent in their dues at the last known address. The members name will be posted in the Pro Shop and Clubhouse indicating suspension of club privileges.
